Listed Company Information

National Flour Mills Limited (NFM) - 05.07.2024

The Trinidad and Tobago Stock Exchange (TTSE) received notice from NFM advising that Mrs. Aliyah Hamel-Smith tendered her resignation as a Director effective June 28, 2024.

CinemaOne Limited (CINE1) - 04.07.2024

The TTSE received notice from CINE1 advising that at a Board Meeting held on June 28, 2024 the Directors approved a Shareholder Loyalty Programme / Dividend-in-Kind in which each shareholder will be entitled to a voucher redeemable in movie tickets, food and beverage services, theatre facility use, screen advertising and / or in-theatre advertising valued at TT \$0.13 per share.

CINE1 further advised that the Starz Shareholder Loyalty Program / Dividend-in-Kind distribution will be to shareholders on the register as at July 12, 2024 and the 2024 CINE1 Starz Shareholder Loyalty Programme / Dividend-in-Kind vouchers will be distributed on July 19, 2024.

Trinidad Cement Limited (WCO) - 03.07.2024

The TTSE received notice from TCL advising of the following changes to the Executive Managment of TCL effective July 1, 2024:

- Mr. Gonzalo Rueda Castillo replaced Mr. Guillermo Rojo de Diego as General Manager of TCL. Mr. Rojo held the position from February 6, 2019, and will be supporting the transition for a period of time. Under this portfolio, Mr. Rueda will also oversee the operations of TCL's business units in Trinidad, Barbados and Guyana. Mr. Rueda has over 25 years professional experience, and most recently held the postion of Vice President - Commercial, at Cernex Colombia.
- Mr. Roberto Adrian Villarreal Villarreal will replace Mr. Gustavo Alejandro Ruiz Silva as Group Strategic Planning Manager. Mr. Ruiz held the position from September 1, 2021 and will take up another position within the Cemex Group. Mr. Villarreal has been domiciled in the Caribbean for over 10 years, and most recently held the position of General Manager with the responsibility of the operations of TCL's business units in Barbados and Guyana, namely Arawak Cement Company Limited and TCL Guyana Incorporated.
