Guardian Holdings Limited (GHL) and NCB Financial Group Limited (NCBFG) - 21.11.2024

The TTSE received notice from GHL advising that on November 19, 2024, its Board of Directors approved the execution of a Sale and Purchase Agreement ("SPA") with PIB Group Limited ("PIB Group") for the sale of 100 percent of the shares of Thoma Exploitatie B.V.("Thoma Group"). They further advised that the Thoma Group is Guardian Group Fatum's Insurance Brokerage business in the Netherlands and the transaction, which was effected through a closed sale process, aligns with the Company's strategic priorities to maximise shareholder value.
